First aid procedures

General

Call a POISON CENTER or doctor/physician if you feel unwell. Show this SDS.

Inhalation

If breathing is difficult, remove victim to fresh air and keep at rest in a position comfortable for breathing. Get medical attention if any discomfort continues.

Skin contact

Flush skin thoroughly with water. Take off contaminated clothing and wash before reuse. If skin irritation occurs: Get medical advice/attention.

Eye contact

Promptly wash eyes with plenty of water while lifting the eye lids. Remove contact lenses, if present and easy to do. Continue rinsing. Get medical attention immediately! Continue flushing during transport to hospital.

Ingestion

Rinse mouth thoroughly. Drink a few glasses of water or milk. Get immediate medical advice/attention.

Limitation of exposure on workplace

Personal protection equipment should be chosen according to the CEN standards and in discussion with the supplier of the personal protective equipment. Protective gloves and goggles are recommended. An eye wash bottle must be available at the work site.

Eye protection

Use approved safety glasses, goggles or face shield. Safety glasses should have side shields.

Suitable eye protection

Safety glasses should have side shields.

Additional eye protection measures

Provide easy access to water supply and eye wash facilities.

Hand protection

Chemical resistant gloves required for prolonged or repeated contact.

Skin- / hand protection, long term contact

Butylrubber:

Penetration time: ≥ 480 min

Material thickness: $\geq 0,7$ mm

Suitable materials

Butyl rubber. Nitrile. Chloroprene rubber. Polyvinyl chloride (PVC). Rubber (natural, latex).

Respiratory protection

Under normal conditions of use respiration protection should not be required.

Skin protection (except hands)	No special precautions.

Fire fighting measures

Suitable extinguishing media	Water spray, foam, dry powder or carbon dioxide.
