### General

Use of the substance / mixture

Handgerileyör AISE-P1300: Professional hand cleaner / disinfectant.

### First aid procedures

General

Call a POISON CENTER or doctor/physician if you feel unwell. Show this SDS.

Inhalation

If breathing is difficult, remove victim to fresh air and keep at rest in a position comfortable for breathing. Get medical attention if any discomfort continues.

Skin contact

Flush skin thoroughly with water. If skin irritation occurs: Get medical advice/attention.

Eye contact

Promptly wash eyes with plenty of water while lifting the eye lids. Remove contact lenses, if present and easy to do. Continue rinsing. Get medical attention immediately! Continue flushing during transport to hospital.

Ingestion

Rinse mouth thoroughly. Do not induce vomiting. Get immediate medical advice/attention.

Acute symptoms and effects

Irritation of eyes and mucous membranes, dilated pupils, respiratory irritation, breathing problems. Nausea/vomiting, depression, sleepiness, dizziness. See further section 11.1 under "Potential Acute Effects"

### Protective equipment

Limitation of exposure on workplace

Personal protection equipment should be chosen according to the CEN standards and in discussion with the supplier of the personal protective equipment. Protective gloves and goggles are recommended. An eye wash bottle must be available at the work site.

Eye protection

Not considered necessary under ordinary use conditions.

Hand protection

Not applicable.

Respiratory protection

Under normal conditions of use respiration protection should not be required.

### Fire fighting measures

Suitable extinguishing media

Foam, carbon dioxide or dry powder. Water spray.

Fire and explosion hazards

Flammable liquid and vapour.

Fire fighting procedures

Fight fire with normal precautions from a reasonable distance.

Personal protective equipment

Wear respiratory protection. Wear protective gloves / protective clothing / eye protection / face protection.

Stop leak if safe to do so.

Personal protection measures

Wear protective clothing as described in Section 8 of this safety data sheet. Do not breathe vapour. If breathing is difficult, remove victim to fresh air and keep at rest in a position comfortable for
